#### **GENERAL INFORMATION**

These are general descriptions of policy types and coverages and is not intended to be relied upon as complete.

There are basic forms of coverage in all types of insurance, including title insurance. One widely used title insurance policy in California is the California Land Title Association (CLTA) Standard Coverage Policy written for an owner, lender, lessee, or for the holder of other estates or interest in the land.

The Standard Coverage Policy, while insuring the vesting and marketability of title, protects the insured owner against loss from defects, liens, or encumbrances not excluded or excepted from coverage. In addition, an insured trust deed beneficiary is covered as to validity of the lien of the trust deed and its priority shown in the policy. Other risks covered by the Standard Coverage Policy include forgery, documents executed by minors or incompetents whose disability is not disclosed by public records, and similar matters.

It is not practical to explain in detail all risks that are excluded or excepted from this policy but they include, among others, matters ascertainable by inspection or a survey of the property and certain other unrecorded matters. Certain of the items excluded or excepted from the Standard Coverage Policy are covered by the extended coverage form of the American Land Title Association (ALTA) Homeowner's Policy, and ALTA Lender's Policy.

Numerous endorsement forms have been adopted to provide additional title insurance coverage dealing with insurance risks beyond the scope and coverage of the basic policy.

The Homeowner's Policy provides enhanced coverage concerning pre- and post-policy issues, access, encroachment, protection against violations caused by restrictive covenants, building permit requirements<sup>1</sup>, subdivision law<sup>1</sup>, water and mineral rights damage, supplemental tax liens, and map inconsistencies.

There also exist several types of guarantees which serve specific purposes, generally indicated by the name. For example, the Trustee's Sale Guarantee (TSG) is designed to aid a trustee in conducting a nonjudicial foreclosure of a deed of trust. Coverage afforded by guarantees is limited to a particular condition of title, period of time, and type of information that is evident when the content of each guarantee is examined.
